- The registrant(s) must submit the following **personally (for new registrant) or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor (for registrant who has previously registered under the “Information on Sales Arrangements No.1” of the Phase of the Development)** to the Sales Office at or before 2 p.m. on the day before the First Date of the Sale (“the Deadline of Submission”):-

- i) Balloting of Group A will take place on 10 May 2019. The ballot results, including “registration number”, “ballot result sequence” and “the check-in timeslot for registrants” shall be posted at the 19/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong at or before 12:00 p.m. on 10 May 2019. The registrant(s) will not be separately notified of the ballot results.

The Group A registrant(s) who arrive at the Additional Designated Venue at any time later than “the check-in timeslot for registrants” assigned in the ballot results shall not be eligible to select the specified residential properties according to the ballot results.

Any changes to the time of the Group A Unit Selection will be announced at the Sales Office. Registrants will not be notified separately of such changes.
