Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their "check-in timeslot" shall not be eligible for participating in Part 1 of Session A.
 - (b) On the First Day of Sale, a registrant who pre-registered for Part 2 of Session A (if the registrant is a corporation, then **all of its directors**) must bring along his/her/their original H.K.I.D.
