On the First Day of Sale

Section (I) - Abstract

- The sale of the specified residential properties will be divided into the following 2 sessions (namely Session A and Session B). Any person interested in purchasing any of the specified residential properties (the “registrant”) may participate in both Session A and Session B, or only in Session A or only in Session B. Registrants which are not individuals are not allowed to participate in Session A and/or Session B.

Section (II) - Submission of Registration of Intent for Session A and Session B before the First Day of Sale

- Registrants must follow the procedures below.
- A registrant must **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) submit the following:-
 - Not more than 3 Registrations of Intent duly completed and signed by the registrant;
 - the Registration of Intent shall be accompanied with cashier order(s)/cheque(s) each in the sum of HK\$50,000 and made payable to “**MAYER BROWN**”. The number of cashier order(s)/cheques(s) shall be equal to the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent. The Vendor reserves its absolute discretion to accept or reject any cheque;
 - a copy of the registrant’s H.K.I.D. Card(s)/Passport(s)

to the ICC Venue after the relevant price list(s) of the specified residential properties are made available till 27 April 2023 (both dates inclusive) during office hours (from 12:00 noon to 7:00 p.m. on 22 April 2023 to 23 April 2023; from

2:00 p.m. to 8:00 p.m. on 24 April 2023 to 26 April 2023; from 12:00 noon to 1:00 p.m. on 27 April 2023). The closing time for submission of Registration of Intent will be 1:00 p.m. on 27 April 2023. Late submission or submission outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the registrant will be given a receipt of Registration of Intent.

Section (III) – Pre-registration for Part 1 of Session A and Part 2 of Session A before the First Day of Sale

4. Pre-registration for Part 1 of Session A before the First Day of Sale

- (a) A registrant interested in participating in Part 1 of Session A must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Registration of Intent and **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) attend the ICC Venue on 27 April 2023 during office hours (from 5:00 p.m. to 5:15 p.m.) to register to participate in Part 1 of Session A. The closing time for registration to participate in Part 1 of Session A will be 5:15 p.m. on 27 April 2023. Late registration or registration outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the original receipt of Registration of Intent of the registrant will be chopped with a chop (the “**Session A1 Chop**”), to signify the completion of pre-registration of Part 1 of Session A by the registrant.
- (b) Only registrants who have pre-registered to participate in Part 1 of Session A in accordance with paragraph 4 and who have obtained a Session A1 Chop on its original receipt of Registration of Intent will be included in the balloting for Part 1 of Session A in accordance with Section (IV). For the avoidance of doubt, a registrant may participate in both Part 1 of Session A and Part 2 of Session A, or only in Part 1 of Session A or only in Part 2 of Session A.

5. Pre-registration for Part 2 of Session A before the First Day of Sale

- (a) A registrant interested in participating in Part 2 of Session A must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Registration of Intent and **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) attend the ICC Venue on 27 April 2023 during office hours (from 5:45 p.m. to 6:00 p.m.) to register to participate in Part 2 of Session A. The closing time for registration to participate in Part 2 of Session A will be 6:00 p.m. on 27 April 2023. Late registration or registration outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the original receipt of Registration of Intent of the registrant will be chopped with a chop (the “**Session A2 Chop**”), to signify the completion of pre-registration of Part 2 of Session A by the registrant.
- (b) Only registrants who have pre-registered to participate in Part 2 of Session A in accordance with paragraph 5 and who have obtained a Session A2 Chop on its original receipt of Registration of Intent will be included in the balloting for Part 2 of Session A in accordance with Section (IV). For the avoidance of doubt, a registrant may participate in both Part 1 of Session A and Part 2 of Session A, or only in Part 1 of Session A or only in Part 2 of Session A.

Section (IV) – Balloting for Session A and Session B before the First Day of Sale

6. Separate balloting will be used to determine the order of priority in selecting the specified residential properties in Part 1 and Part 2 of Session A and Session B respectively :-

- (a) For Part 1 of Session A, the first round balloting will be carried out to divide the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or take place at ICC Venue on 28 April 2023 at or after 3:00 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (“**ICC Lobby**”) and on the website (www.universityhill.com.hk) designated by the Vendor for the Phase (“**Designated Website**”) after 7:00 p.m. on 28 April 2023. Registrants will not be separately notified.
- (b) For Part 2 of Session A, the first round balloting will be carried out to divide the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or on 28 April 2023 at or after 3:15 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 28 April 2023. Registrants will not be separately notified.
- (c) For Session B, the first round balloting will be carried out to divided the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each

registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or on 28 April 2023 at or after 4:00 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 28 April 2023. Registrants will not be separately notified.

7. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC Venue and/or facilitating smooth balloting and/or due to the reasons set out in paragraph 33 below, to adjust the date, time and location of the balloting. Any changes to the date, time and location of the balloting will be posted at the ICC Venue and at the ICC Lobby. Registrants will not be notified separately of such changes.
8.
 - (a) In respect of Part 1 of Session A, every registrant shall be allotted one lot.
 - (b) In respect of Part 2 of Session A, every registrant shall be allotted one lot.
 - (c) In respect of Session B, every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent. Once a lot allocated to a Registration of Intent of a registrant has been successfully drawn, all other lot(s) (if any) relating to the same registrant shall be automatically included in a group with the lowest order of priority amongst other group(s) in Session B for the purpose of balloting. The number of specified residential property(ies) that the registrant of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant intends to purchase as indicated in the Registration of Intent.
9. The results of the balloting, including "registration number", "ballot result sequence" (if applicable) and "check-in timeslot" for Part 1 of Session A, Part 2 of Session A and Session B will be announced and/or posted up at the ICC Venue and (if applicable) the ICC Lobby and on the Designated Website after 7:00 p.m. on 28 April 2023. Registrants will not be separately notified of the ballot results.

Section (V) - Procedures for Session A on the First Day of Sale

10. Registrants interested in purchasing any specified residential properties in Session A in the manner prescribed in the Abstract in Section (I) must follow the procedures specified in Sections (I), (II), (III) (if applicable), (IV), (V) and (VII).
 - (a) On the First Day of Sale, a registrant who pre-registered for Part 1 of Session A must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Registration of Intent and **personally** attend the ICC Venue according to the "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 9 above. Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their "check-in timeslot" shall not be eligible for participating in Part 1 of Session A .
 - (b) On the First Day of Sale, a registrant who pre-registered for Part 2 of Session A must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Registration of Intent and **personally** attend the ICC Venue according to the "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 9 above. Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their "check-in timeslot" shall not be eligible for participating in Part 2 of Session A .
 - (c) In case the ICC Venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason direct the registrants to attend the lobby on 3/F and/or 10/F and/or 21/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (collectively the "**Additional Venues**") by making announcement at the ICC Venue and the Additional Venues.
11. After verification of the identity of registrants by the Vendor, Session A will be proceeded in 2 parts and, subject to paragraph 18 below, in the following order, namely, Part 1 and Part 2.

Part 1 and Part 2 of Session A

12. A registrant who has already selected and purchased any specified residential property in Part 1 of Session A will not be allowed to participate in Part 2 of Session A, and his/her/their/its order of priority in Part 2 of Session A shall lapse automatically. For avoidance of doubt, a registrant who has pre-registered to participate in Part 1 of Session A in accordance with the registration procedures set out in paragraph 4 above and who has not purchased any specified residential property in Part 1 of Session A will still be allowed to participate in Part 2 of Session A (provided that the registrant has pre-registered for Part 2 of Session A in accordance with the registration procedures set out in paragraph 5 above).

13. (a) (If the Vendor has carried out the second round balloting for Part 1 of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 1 of Session A will be determined by the "ballot result sequence" announced and/or posted by the Vendor pursuant to paragraph 9 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 1 of Session A will be determined by balloting in batches on spot.
- (b) (If the Vendor has carried out the second round balloting for Part 2 of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 2 of Session A will be determined by the "ballot result sequence" announced and/or posted by the Vendor pursuant to paragraph 9 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 2 of Session A will be determined by balloting in batches on spot.
14. Registrants shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority determined pursuant to paragraph 13 above and in an orderly manner and within reasonable time.
15. The registrants shall **in compliance with the rules set out in the Abstract in Section (I) applicable to that Part of Session A** select and purchase specified residential properties, otherwise his/her/their/its order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in that Part of Session A.
16. For each specified residential property purchased by the registrant, part of preliminary deposit in the following sum shall be paid by cashier order(s) :-
- (a) Part 1 of Session A
- (i) Additional HK\$300,000 for each Designated Session A Unit; and
- (ii) Additional HK\$100,000 for each other specified residential property.
- (b) Part 2 of Session A
- (i) Additional HK\$300,000 for each Designated Session A Unit; and
- (ii) Additional HK\$100,000 for each other specified residential property.
17. In addition to using one cashier order/cheque submitted with the Registration of Intent for each specified residential property purchased by the registrant, the registrant shall submit on spot to the Vendor sufficient additional cashier order(s)/cheque(s) made payable to "**MAYER BROWN**" for payment of part of preliminary deposit of the specified residential property(ies) as stated above.
- If the number of specified residential properties the registrant purchases in a Part of Session A exceeds the number of cashier order(s)/cheque(s) submitted with the Registration of Intent, the registrant shall submit on spot to the Vendor sufficient additional cashier order(s)/cheque(s) made payable to "**MAYER BROWN**" for payment of part of preliminary deposit of each extra specified residential property as stated above.
- In case of any dispute, the decision of the Vendor shall be final and conclusive.
18. If the remaining specified residential properties available for selection and purchase in a Part of Session A is such that the rules for that Part of Session A as set out in the Abstract in Section (I) cannot be satisfied, then:-
- (a) (in the case of Part 1 of Session A) Part 1 of Session A will end and the remaining Session A Units will be offered for sale in Part 2 of Session A; and
- (b) (in the case of Part 2 of Session A) Part 2 of Session A will end and the remaining Session A Units will be offered for sale in Session B.
19. A registrant who leaves the ICC Venue and/or (if applicable) the Additional Venues while his/her/their/its group is in session for selecting and purchasing specified residential properties shall be disqualified for participating in the selection and purchase of specified residential properties in that Part of Session A and his/her/their/its order of priority in that Part of Session A shall lapse immediately.
20. If a registrant has successfully selected the specified residential property(ies) in compliance with the rules set out in the Abstract in Section (I), the registrant shall **personally** enter into one or more preliminary agreement(s) for sale and purchase of the selected specified residential property(ies). If the registrant does not enter into all preliminary agreement(s) for sale and purchase of all the selected specified residential properties, he/she/they/it would be deemed to have given up those specified residential properties and his/her/their/its order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in that Part of Session A.

- (a) Before entering into the preliminary agreement(s) for sale and purchase in respect of the selected specified residential properties, a registrant may request the Vendor on spot to add his/her **close relative(s)** (as defined in paragraph 29(a) below) as joint purchasers and/or delete the registrant's name from the preliminary agreement(s) for sale and purchase in accordance with the requirements specified under paragraph 29 below.
- (b) If a registrant has successfully purchased specified residential property(ies) in Part 1 and/or Part 2 of Session A and still has unused cashier order/cheque submitted with the Registration of Intent, the registrant shall still be eligible to participate in Session B to purchase specified residential property(ies).

Section (VI) - Procedures for Session B on the First Day of Sale

- 21. Registrants interested in purchasing any of the specified residential properties in Session B in the manner prescribed in Section (I) must follow the procedures specified in Sections (I), (II), (IV), (VI) and (VII).
- 22. The order of priority for selection of the specified residential properties in Session B will be determined by the "ballot result sequence" announced and/or posted by the Vendor pursuant to paragraph 9 above.
- 23.
 - (a) On the First Day of Sale, the registrants must bring along his/her/their original H.K.I.D. Card(s)/Passport(s) and the original receipt of Registration of Intent and **personally** attend the ICC Venue according to "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 9 above. Registrants who arrive at the ICC Venue or (if directed by the Vendor) the Additional Venues beyond their "check-in timeslot" shall not be eligible to participate in Session B.
 - (b) In case the ICC Venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason, make use of the Additional Venues to accommodate some of the registrants by making announcement and/or posting notice(s) at the ICC Venue and the Additional Venues.
- 24.
